Further, the shareholding of members of Jainalco Industries Limited is as follows: Abhishek Jain: 49.997% Parag Jain: 49.997% Anju Jain: 0.002% Punita Jain: 0.001% Princy Jain: 0.001% Ashima Goyal: 0.001% One Public Shareholder: 0.001% All the shareholders except the public shareholder are Acting together as Person in Concert. And therefore holding majority stake (i.e 99.999%) in Jainalco Industries Limited. Hence the 30.28% holding of Jainalco Industries Limited in Worldwide Leather Exports Limited, will be considered to be held by the 6 individuals as mentioned above. Out of the 6 Individuals, 5 individuals except Ashima Goyal are also holding direct holdings in Worldwide Leather Exports Limited as follows: Abhishek Jain: 2.1909% Parag Jain: 2.3735% Anju Jain: 11.8153% Punita Jain: 0.8216% Princy Jain: 0.8216% Clubbing of Direct and Indirect Holdings will be as follows: (Considering the 30.2807% stake of Jainalco in Worldwide, as the stake of Individual SBO in Worldwide Leather Exports Limited) Abhishek Jain: $(30.2807 + 2.1909)\% = 32.4716\%$ Parag Jain: $(30.2807 + 2.3735)\% = 32.6542\%$ Anju Jain: $(30.2807 + 11.8153)\% = 42.096\%$ Punita Jain: $(30.2807 + 0.8216)\% = 31.1023\%$ Princy Jain: $(30.2807 + 0.8216)\% = 31.1023\%$ Ashima Goyal: 30.2807% Since the Column Q in the SBO Sheet is not allowing to fill the entries whose sum exceeds 100%.
