- 1.4 I have downloaded the data of e-voting from the E- Voting website of Central Depository Services (India) Limited (https://www.evotingindia.com/) after the E-voting module was disabled by the Central Depository Services India Limited (CDSL) on 17th January, 2018 at 10:41 A.M.
